2. All equipment, trash, and items must be removed at the end of the event. Trash cans will be available on site.
3. Redford Ranch Foundation does not assume any liability or responsibility for vendors, their equipment, merchandise, or personal items.
4. No parked vehicles in the Vendor area after 10AM. .
5. Vendors must set up and tear down; Redford Ranch Foundation and event coordinators do not provide any equipment or supplies for vendors. No power, water, etc will be available. All vendors must be self-contained.
6. Any generators must be reasonably quiet. Vendors planning to use generators MUST notify Redford Ranch Foundation on registration form.
7. Vendors and food trucks must comply with all local and state laws. Permits and inspections will be required.
8. The event organizers reserve the right to deny an application or ask a non-compliant vendor to leave the event.
